#### 5. Publicity Report

The stand then attended the Royal Welsh show and was again successful show. The stand was closed on the Monday for judging but the other three days it was very busy. Thank you to Gareth Vince for supplying the ram, ewe and cross bred lamb. David wood took information leaflets and a few merchandise to publicize the breed in Chertsey show as well I must say a big thank you to all the members who volunteered and gave their time to help out on the stand in all the events this year, without all of your help it would not be possible to have a publicity stand at these events, also to Tudor Gethin for looking after the trailer and transporting it to the shows.

## 6. Website Report

WEBSITE REPORT as of END OF OCTOBER 2018

- 54,814 visits to the website since January 2018, with an increase month on month (from 4765 in January to a peak to 6641 in August and 6119 in October), currently achieving 200-250 visitors a day, and a fairly steady 1500 visitors each week.
- Members are selling their sheep quickly through the website. Photographs of sheep for sale could be improved by taking them side on, not from a standing position which doesn't do the sheep justice accordingly a tip to sellers has been put on the website selling page.
- The banner photographs on the website have been changed to show the 2018 Torddu and Torwen champions from the Society Show and Sale. Very nice quality images of the sheep were provided but it's a shame the heads of their owners were not included we have them up to their chins!
- There are currently 357 society members. There are now 340 members of the closed facebook group open to society members and their immediate family. It continues to be very well used.
- 975 people follow the public facebook page. The Society Secretary and Dafydd Williams have been given admin rights for this page.
- Family membership details have been put onto the membership application form and uploaded onto the website.
- There has been a suggestion that the crossing attributes of the Badger Face should be shared information about this with suitable photographs of various crosses could be put on the website.
- I noted from the last minutes that only shows that have had panel judges should have pictures on the website. Please point me to a list of shows with panel judges so that I can comply.

#### 9. Amend Rule 8 to read

The Membership Subscription and Registration Fees shall be as the Society determines. Junior members should be aged 16 or under on 1st January of subscription year. All subscriptions are to be paid by 31st March. If these are not paid you are deemed not to be a member, and will incur a re-joining fee of double the subscription fee.

Unanimously agreed by all.

#### Amend Rule 15 to read

The Society shall appoint 3 persons, from within the officials of the Society (either committee members or officers), to investigate and report on cases of doubtful or suspect pedigrees. The Society reserves the right to remove any members whose conduct, in its opinion, is or has been detrimental or prejudicial to the interests of the Society or Breed. In order to investigate a complaint, it must be received by the Secretary within 6 weeks of the incident. The Society will commence any investigation within 2 weeks of receipt of the complaint. Unanimously agreed by all.

**Amend wording of Rule 19 to read -** Exhibitors shall not, under any circumstances, artificially colour the fleece or existing markings by any means. It will be investigated as per Rule 15.

Unanimously agreed by all.

**Proposed New Rule -** Provisional judges to have a minimum two years judging experience and to have judged 5 shows in two or more years. A maximum of three shows only to be judged by any judge during one year. Each provisional judge to send a CV into the committee meeting before the AGM in order to be approved for promotion at the AGM. A provisional judge must not judge a county show and it is

the individual members' responsibility to inform the show that they are not qualified to judge at County level. Judges to be sent a set of rules when they are appointed as a provisional judge. A judge to be a fully paid up member in their own right. Unanimously agreed by all.

## **Nomination of Judges:**

A short discussion was had regarding shows using non-panel judges. Even though shows cannot be forced to use panel judges, shows need to be reminded that having a Society judge would attract more exhibitors. The letter enclosed with the list of judges to shows should explain the points system the Society has in place. The following were nominated as new judges:

There was also a discussion here regarding the family membership. It was agreed that the family membership allows for 2 votes and 2 judges if circumstance arises.

#### **Any Other Business**

Rare Breeds Trust – It is possible for us to get the Torwens as a Rare Breed. There is a PHD on genetics of Welsh sheep which proves that there is enough DNA difference for the Torwen sheep to be classed as a rare breed. This would give the Society some protection if there was a disease outbreak. There is a Breeds at Risk Register held by the UK Government and a register of Welsh Sheep that need protection held by the Welsh Government. This can only be good for the breed. It was proposed by Brian Eagles, seconded by Mathew Brown and agreed by all to proceed with this.

Professional photos at shows – It was agreed that Chrissie Long would be asked to photograph at the Spring Festival; Royal Welsh Show and NSA Show & Sale. She would also be asked to take Champion Photos at any show she was present.

NSA Show and Sale Catalogue – Enfys provided a proof of the 2019 catalogue and a quote of £420 plus £25 artwork. It was agreed to produce a catalogue of this standard from 2019 onwards.

The standard of stock was raised. It seems that the top end of the breed is going from strength to strength and the bottom end is getting worse. The quality of Torwens has decreased incredibly. It was agreed to hold an open day with the aim of encouraging new members to attend in order to understand what the standard of the breed is. It was noted that the Society has enough funds and it is time that the Society gave something back to its members.

Sale of Badgerface Sheep in England – Josh Brigg noted that Brian Eagles had raised the fact that members from outside of Wales feel very isolated from the Society. As a means of addressing this Josh proposes that we look into the possibility of holding a sale as part of the traditional Native Breeds National Show and Sale held annually in September at Melton Mowbray in Leicestershire. This has been running for many years, the 2019 Sale, on 13<sup>th</sup> and 14<sup>th</sup> September, will be the 17<sup>th</sup>, and is now a well-established and principal sale for nearly thirty native sheep breeds. It was agreed to look into the possibility of this and to discuss throughout the year and bring back to next year's AGM.

A flock competition was proposed and agreed. Expenses to be paid to the judges. The Show points' competition is struggling to get entries, this in part maybe because not everyone wants to show and the 6 day rule is also restrictive. The flock competition was proposed by Huw Williams and seconded by Timothy Evans and agreed by all. It was agreed that the competition should be held in the autumn. This would also give new members an opportunity to receive feedback on their stock.

## **Venue of next AGM**

It was agreed that the Spring Meeting will be held on Saturday 27 April 2019 at Builth Wells and that the 2019 AGM will be held on Saturday 2 November – location to be confirmed.

The meeting was declared closed at 5.15pm.
